## AN ARCOSA COMPANY

### STANDARD TERMS AND CONDITIONS

**MATERIALS SOLD:** Recycled Aggregate Materials Company Inc. (hereinafter "Seller") sells Crushed Miscellaneous Base and Processed Miscellaneous Base pursuant to the Green Book Standard Specifications for Public Works Construction, Section 200-2 and Class 2 Aggregate Base per Caltrans Standard Specifications Section 26-1.02A, all of which products are manufactured **only** from recycled materials.

**DELIVERY:** Seller makes no promises, warranty, or representation as to the total quantity of materials to be provided by Seller or as to the rate at which it will deliver materials to Buyer. All deliveries and the rate thereof are dependent upon the availability of trucking, raw material and/or material in stockpile. All quotations which include haul or delivery prices are based upon deliveries Monday through Friday during normal working hours: prices for weekend and other off-time deliveries are available upon specific request of Customer.

PAYMENT TERMS: Net 10th and all delinquent accounts will be liable for a service and finance charge of 1.5% per month (18% annual rate).

SALES TAX: All prices for seller's goods include sales tax on the material sold F.O.B. Seller's plant.

**HAUL CHARGES:** All quotations that include a price for hauling are subject to increase by Seller if Seller experiences any increases in the cost of hauling after the date of the quotation. All deliveries are subject to a 25-ton minimum hauling charge.

**DURATION OF QUOTATION:** All quotations are firm prices for 90 days after the date of the quotation; all prices are subject to revision by Seller after expiration of the 90 day period.

**TESTING:** Seller performs laboratory tests only of materials in stockpile which tests are available upon request. Seller warrants and represents that the tests it takes of its material in stockpile are accurate. Seller does not make any promises, warranties or representations concerning the quality or gradation of its products once they have been removed from stockpile. Seller is not responsible for any testing of any kind other than as set forth in this paragraph. Seller has made reasonable efforts to see that materials are free from extraneous substances and hazardous materials but seller cannot warrant recycled materials to be free from such substances.

**TITLE:** Title to and the risk of loss of goods sold by Seller to Buyer shall pass to the Buyer upon the Seller's loading of the goods into any transportation vehicle at Seller's manufacturing facility.

**LIMITED REMEDIES:** Seller's liability and Buyer's <u>exclusive remedy</u> against Seller arising out of or in any way related to any sales between Seller and Buyer is expressly limited, at Seller's option to: (a) replacement of non-conforming goods F.O.B. Seller's point of delivery or (b) payment to Buyer not to exceed the purchase price for the shipment or shipments which are in dispute.

WITHOUT LIMITATION ON THE FOREGOING, SELLER SHALL NOT BE OBLIGATED FOR LOST PROFITS, LIQUIDATED DAMAGES, DELAY COSTS INCLUDING BUT NOT LIMITED TO TRUCKING DELAYS OF ANY KIND, OR ANY OTHER SPECIAL, CONSEQUENTIAL OR INCIDENTAL DAMAGES WHETHER ARISING UNDER WARRANTY, FAILURE OF ESSENTIAL PURPOSE, GUARANTEE, CONTRACT, TORT, STRICT LIABILITY, VIOLATION OF LAW, OR OTHERWISE.

**INDEMNITY:** Buyer shall indemnify and defend Seller from any claim, lawsuit, or demand by any third persons and pay all amounts due, including attorney fees and costs incurred by Recycled Aggregate Materials Company Inc., for which Seller is deemed liable, or to which Seller might become liable, which results from or is anyway related to the sale, resale, transfer, use, misuse or disposal of goods sold by Seller to Buyer.

**ATTORNEYS FEES/ARBITRATION:** If a dispute arises out of or relates to a sales transaction between Seller and Buyer, the prevailing party shall be entitled to recover its actual attorney's fees and costs including the payment of expert witness, arbitrator's fees, and administrative fees in relation thereto, whether or not the dispute ever proceeds to litigation or judgment. Buyer also agrees to pay all actual attorney's fees and costs, including the payment of expert witnesses, in any proceeding brought by Seller to enforce any mechanic's lien, stop notice or bond rights arising from the sale of materials to Buyer.
